A state-wide organisation promoting and protecting the rights of people from non-English speaking backgrounds with disability and their families and carers



At MDAA we do:

Individual Advocacy: We promote and protect the rights of people from non-English speaking backgrounds (NESB) with disability and their families and carers in NSW.

We help people to stand up for their rights, for example, when people have problems with housing, immigration, school, work and disability services. We do this for people from NESB with all types of disability and their families and carers. We do this across NSW and have offices in Sydney, Wollongong, Newcastle, Griffith and Bega.

Systemic Advocacy: We work to change policies, procedures, practices and service delivery in government and non-government agencies.

Advocacy Development: We work to change attitudes and increase awareness among communities, with a focus on disability and ethnic communities.

We do this through the regional 'Advocacy in Action' project, community information days, community outreach, training and information sessions for people with disability.

Industry Development: We work with communities, private and government agencies to increase knowledge and understanding about the issues facing people from NESB with disability.

We do this by developing resources, providing information, advice and hands-on support to agencies and through our Community Voices project.

Training and Education: We provide training and education in cultural diversity and disability.

mdaa cultural abilities, our fee-for-service training and support service can provide tailored training and skills development, undertake cultural competence audits, assist in developing action plans and provide other services.



About MDAA

MDAA aims to promote, protect and secure the rights and interests of people from NESB with disability and their families and carers in NSW.

MDAA is the peak body for people from NESB with disability and their families and carers in NSW.

MDAA is a community based, non-government organisation run by a Committee elected by members.

The majority of people on the Committee are from different cultural backgrounds and with different disabilities.

MDAA is a member organisation made up of people from NESB with disability, family members, carers, friends and organisations. New members are always welcome.

MDAA is funded mainly by the NSW Department of Ageing, Disability and Home Care and the Commonwealth Department of Families, Housing, Community Services and Indigenous Affairs.

MDAA has an affirmative action employment policy and staff are from many cultural backgrounds and may have a disability.

MDAA is a tax deductible gift recipient and gifts over \$2.00 are tax deductible.
